1.0 Academic Research:

Admission of Ph.D scholars, Research progress, Thesis submission, Publication, Guideships is governed & abided by the Visvesvaraya Technological University guidelines for Ph. D/ MSc Engineering by research.

2.0 Sponsored / Collaborative Research Project

2.1 The faculty shall apply for funding support from the Govt / Industries, to do Sponsored/ Collaborative research based on the call for proposals from the agencies.

2.2 The research proposals are reviewed by the Research Committee (RC) at the Institute level before submission of any proposal.

2.3 The Research Committee shall forward the proposals upon review to the Principal for approval towards the submission of proposals to the funding agencies.

2.4. The Principal Investigator (PI) shall then submit the proposal application along with necessary documents to the Funding Agencies.

2.5 Upon sanction of the project by the funding agency, the PIs shall create a new Head of A/c and prepare a Stock Register with proper entries of purchase of recurring and Non-Recurring items.

2.6 The PIs shall appoint a Research fellow (if needed) by advertising and then selection shall be done by conducting the interview based on the budget approval of the funding agency. The interview panel should be constituted with one external expert member along with PI, HOD & Principal.

2.7 The PIs shall present the Progress before the Research Committee (Once in six months).

2.8 Upon completion of the project, the PIs shall prepare Project Completion Report as per the guidelines of the funding agency.

2.9 The research account shall be audited by the Auditor. The PIs shall prepare the Utilization Certificate duly signed by the Auditor.

2.10 The PIs shall submit the Project Completion Report, Utilization Certificate and Publications / patent list to the Sponsoring agency through the Principal of the Institute.

2.11 All the publications resulting from the approved research shall carry the Institute's affiliation along with the PI name.

2.12 All the patents resulting from the said research shall be filed jointly in the name of the Institute & the PI.

2.13 upon completion of the intended research work, all the equipments, tools, furnitures & any other facility procured for the said research activity shall be the asset of the Institute.

2.14 The grants sanctioned from DST, AICTE, VTU, ISRO, VGST, etc & any other private sector organisations for Research & MODROBS shall be considered as research grants.

2.15 The Management of the Institute will pay the PI & team 15% of the cost involved in procuring the tools & equipment for the intended project as an incentive for encouragement & motivation.
